

London Raffle Rules – Amended 3/23/2020 Due to COVID-19

Asheville Community Theatre is incorporated as a 501 (c) (3) nonprofit corporation under the laws of the State of North Carolina. The Asheville Community Theatre London Raffle (“London Raffle”) is conducted for the purpose of generating operating funds.

Purchase one or more raffle tickets during London Raffle and you’ll be entered to win a create-your-own theatre trip for two to London, England. Approximate value of the prize is estimated to be \$10,000.00. Only 500 tickets will be sold. The winner will choose either to receive prize as a check for \$10,000.00 (Choice 1) or to work with travel agent David Lloyd of Foothills Travel to customize the trip as specified in prize information below; no cash remuneration will be made for choosing tickets or tours of lesser price. Prize consists solely of items listed in prize information. (Choice 2). Raffle tickets are \$50.00 each and benefit Asheville Community Theatre. Odds of winning are based on the number of ticket entries purchased up to 500. Must be 18 years of age or older. Contest void where prohibited. Raffle begins at 12:01 am on February 7, 2020 and ends at 11:59 pm on June 28, 2020. All times referenced for the London Raffle are Eastern Time.

HOW TO ENTER: There are three ways to enter.

1. Enter online by completing the online entry form and pay entry fee with credit card.
2. Call ACT at 828-254-1320 during regular business hours, Tue-Fri. Provide your entry information (name, address, telephone, email) over the phone along with credit card information.
3. Provide your entry information (name, address, telephone, email) and pay entry fee in person at Asheville Community Theatre Box Office, 35 East Walnut St., Asheville, NC 28801.

Ticket Purchases: Once submitted, London Raffle tickets become the sole property of Asheville Community Theatre and will not be returned or refunded.

ELIGIBILITY: Present employees of Asheville Community Theatre and any immediate family members residing with the employees are not eligible to participate. Must be 18 years or older to enter. Contest void where prohibited. You need not be present to win.

SELECTION AND NOTIFICATION OF WINNERS: Winner will be selected at random and announced on Asheville Community Theatre's Facebook page on **June 30, 2020**. Winner will be notified by telephone, mail and/or email. If potential winner(s) cannot be reached after 10 days from first notification attempt, or if an entrant is found to be ineligible, or a prize notification is returned as undeliverable, such prize will be forfeited and alternate winner(s) will be selected by random drawing. Winner will also be announced in Asheville Community Theatre's e-newsletter and by email to all raffle ticket buyers.

PRIZE SELECTION: **The winner of the Asheville Community Theatre London Raffle will choose between two prizes:**

Choice 1: a check for \$10,000.00 or

Choice 2: to work with David Lloyd of Foothills Travel to choose travel dates and tickets to events of their choosing as specified in prize information below:

- 2 round trip Business Class tickets to London from Charlotte
- Transfers to and from the airport to hotel
- Accommodations for 6 nights in 4-star or higher hotel in central London

- 2 pre-purchased tickets to the theatre (you pick from an exclusive list of West End shows)
- 2 passes to ride the London Eye
- Up to \$500.00 to spend on guided tours or additional theatre tickets
- Personal consultation with travel agent to customize your trip
- Travel must be completed by **December 31, 2021**.

MODIFICATIONS OR CANCELATION OF DRAWING: Asheville Community Theatre reserves the right to cancel or modify the London Raffle. If 250 tickets are not sold by 5 p.m. on **June 28, 2020**, Asheville Community Theatre, at its option, may cancel the London Raffle. In such case ticket purchases will be refunded.

INDEMNIFICATION AND LIMIT ON LIABILITY: As a condition of accepting a prize, winner acknowledges that Asheville Community Theatre is not responsible for any harm, injury, or damage caused to any person or property, proximate or otherwise, through the use of any prize by any person, and agrees to save and hold harmless Asheville Community Theatre, its principals and employees from any claim of such responsibility. "Harm, injury or damage" includes but is not limited to occurrences beyond the control of Asheville Community Theatre such as death, bodily injury, property damage, or theft.

GENERAL: Ticket purchases are non-refundable and are not tax deductible. By entering the raffle, participants agree that Asheville Community Theatre, its agents and employees have no liability whatsoever for any injuries, losses, or damages of any kind which result from the date of award. The prize is non-transferable, and cannot be exchanged for cash. Asheville Community Theatre may use winner's name and likeness for publicity purposes without further compensation. Asheville Community Theatre is not responsible for any failure of communication or

failure of the Internet or its website. Asheville Community Theatre reserves the right to modify these rules and will give prompt announcement of any rule changes. All decisions of Asheville Community Theatre are final and binding in all matters related to this raffle.

TAX OBLIGATIONS: The winner is responsible for all federal taxes. All local and state taxes and fees are the sole responsibility of the winner. For any prizes valued at \$600 or more, Asheville Community Theatre will file IRS Form W2-G with Internal Revenue Service reporting the value of the prize as income to the winner. Winner must show proof of social security number to Asheville Community Theatre. This is for tax recording purposes only, and will be not be used or released for any other purposes.
