**TICKET PURCHASES:** Once submitted, Disney Cruise Raffle tickets become the sole property of Asheville Community Theatre and will not be returned or refunded.

**ELIGIBILITY:** Present employees and Board members of Asheville Community Theatre, and any immediate family members residing with present ACT employees or Board members, are not eligible to participate.
